## **ORDER**

The Travancore Devaswom Board framed rules regarding service Association in the Travancore Devaswom Board (Vide paper No 1)

In the referendum conducted on 10-05-2010 with a view to recognise one Service Association for Travancore Devaswom Board Employees, Travancore Devaswom Employees Front which secured the maximum percentage of votes got recognition (vide paper read 2).

Since the recognition granted on the basis of referendum is valid for 5 (five) years, a fresh referendum to elect the Service Association of Travancore Devaswom Board Employees has to be conducted on the expiry of the validity of the recognition of the elected Service Association.



The Election Board is authorized to take necessary steps to conduct referendum before 15<sup>th</sup> October 2015 the Election Board will also scrutinize the bye laws submitted by Travancore Devaswom Board Staff Organization, Travancore Devaswom Board Employees Federation, Travancore Devaswom Employees Sangh and place their views before the board at the earliest.
