ORDER

The duties, functions and responsibilities attached to the post of Secretary to the Board are voluminous. The Secretary is the Chief Administrative Officer of the Board Secretariat. He occupies in the office of the Board, a position analogous to that of the Chief Secretary in the Secretariat. He represents the Board as contemplated in the Hindu Religious Institutions Act XV of 1950. The responsibilities call for adequate status. Hence the Travancore Devaswom Board in its proceedings dated 20-2-2006 upgraded the post of Secretary, Travancore Devaswom Board to the cadre of Devaswom Commissioner and posted Smt. G. Syamala Devi Thankachi as Secretary. However after the retirement of Smt. G. Syamala Devi Thankachi the post of Secretary, Travancore Devaswom Board was filled up with incumbents in the cadre of Deputy Devaswom commissioner for administrative reasons since 01-07-2007.

The Board discussed the matter in detail and resolved to revive the post of Secretary in the cadre of Devaswom Commissioner as per order dated 23-01-2015 and the Hon'ble High Court ratified the action of Travancore Devaswom Board in the matter of upgradation of the post of Secretary to Devaswom Commissioner cadre by reviving the elevated post as per order dated 30-03-2016 (Ref. 3rd cited).
