ORDER

Consequent on the retirement of Sri. K.K. Suresh Kumar, Assistant Engineer, Aluva on 31-05-2016 and Sri. K. Jagnatha Prathap, Assistant Engineer, Kottarakkara on 31-08-2016, the following promotions, transfers and postings of Assistant Engineers are ordered with immediate effect.


