**ORDER**

As reported by the Chief Engineer (General), in the paper read as 2<sup>nd</sup> paper above regarding the promotions to the post of Assistant Engineer (Non cadre), the following orders are issued in modification to the orders read as 1<sup>st</sup> paper above.

1. Sri. D. Radhakrishna Pillai, 1<sup>st</sup> Grade Overseer [Assistant Engineer (Non cadre)] Office of the Assistant Engineer, Chenganur holding charge of Assistant Engineer, Chenganur on duty basis is provisionally promoted to the cadre of Assistant Engineer in the scale of Rs. 20740 – 36140 against the quota of Graduate Engineer and posted as such at Muvattupuzha in the existing vacancy and allowed to continue as Assistant Engineer, Chenganur on duty basis.
2. Sri. D. Satheesh Kumar, Grade 1<sup>st</sup> Overseer [Assistant Engineer (Non cadre)] holding charge as Assistant Engineer, Board Office on duty basis is provisionally promoted to the cadre of Assistant Engineer in the scale of Rs. 20740 – 36140 against the quota of Graduate Engineer and posted as Assistant Engineer in the existing vacancy in Board Office.

The above provisional promotions are considered since direct recruitment to the post of Assistant Engineer is in stalemate due to several administrative and technical reasons and there was necessity for posting of Assistant Engineers for proper and timely execution of works. This will not be taken as a precedent and will not enable regularization after direct recruitment process begins.

The provisional promotion ordered to the post of Assistant Engineer to Sri. R. Sasikumar, Sri. K.K. Suresh Kumar, Sri. P.G. Shajkumar, Sri. V.P. Chandrasekharan appearing as Serial No. 9, 10, 11 and 13 in the order read as 1<sup>st</sup> paper above is hereby cancelled and they are allowed to continue in the post of Assistant Engineers (Non cadre) in the respective posts in which they were working before the issuance of the order cited above.
