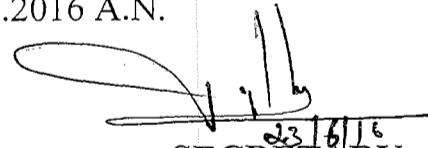
Interview for the post of HSA(Eng) was conducted from 21.4.2014 to 23.4.2014 in which Smt.Preetha.T.Kurup was the 3rd Rank holder and Smt.Mayarani.K the 4th Rank holder.

While giving appointment the 3rd Rank holder Smt.Preetha.T.Kurup was posted against the leave vacancy of Smt.Smitha Mohan at DBHS Kangzha for 6 months, where as Smt.Mayarani.K was offered the post of Smt.Divya.S.Kumar HSA(Eng) DBHSS Parumala who is on leave for 5 years. After the expiry of leave Smt.Smitha Mohan joined duty and as a result Smt.Preetha.T.Kurup was relieved off duties on 31.3.2016. But Mayarani.K, the 4th Rank holder is still continuing at DBHSS Parumala as HSA(Eng).

Smt.Mayarani.K was appointed w.e.f.1.8.2015. The leave period of Smt.Divya.S.Kumar is upto 31.10.19. Though approval was not granted she is continuing in this school from 1.8.2015. As she had completed 8 months as on 31.3.16, she has the eligibility to re-join on 1.6.16. Thus she rejoined on 1.6.2016 at DBHSS Parumala.

Now Smt.Preetha.T.Kurup has represented against this posting of Smt.Mayarani.K. Considering her representation and as she is the 3rd Rank holder, Smt.Preetha.T.Kurup is reappointed as HSA(Eng) at DBHSS Parumala against the leave vacancy of Smt.Divya.S.Kumar w.e.f.24.6.2016.

The posting order issued to Smt.Mayarani.K by ROC.1658/10/Edn dated.1.8.2015 stands cancelled w.e.f.23.6.2016 A.N.
