NOTICE INVITING e-TENDERS FOR EXECUTION OF WORKS

The High Power Committee for Implementation of Sabarimala Master Plan (HPC), Travancore Devaswom Board Head Quarters, Nanthencode, Thiruvananthapuram, invites e-tenders for execution of works/supply, installation and commissioning of machineries from financially sound and well experienced Registered Companies or 'B' Class Contractors/Firms of Kerala PWD/Central PWD/Travancore Devaswom Board in two cover system. The intending tenderers should submit prequalification documents. The Technical Bid (Cover - I) shall contains the details of Earnest Money Deposit of Rs.50,000/- (Rupees Fifty Thousand Only) pledged in favour of the Member Secretary, High Power Committee for Sabarimala Master Plan and scanned copies of the following documents.

- The bidder should be in business as piping and erection work for boilers, food processing, dairy application and related works for a minimum period of 5 years at the time of bid opening in the same style
- The bidder should have supplied, installed, and commissioned at least five similar works and of value of 50% of the estimated cost for single work during last five years, out of which one should be in Govt./Quasi Govt. which is working for minimum of period of one year
- The bidders annual financial turnover in the same style during the last three years shall not be less than the probable amount of contract.
- The bidder have an office/service centre in Kerala to take care of the after sale, service and should be in operation at least for one year.
- The bidders shall provide satisfactory evidence to the High Power Committee for Sabarimala Master Plan regarding their eligibility, capacity and adequacy of resources to carry out contract effectively.

All bids submitted shall include the following information

- Copies of original documents defining the constitution or legal status , place of registration and principal place of business of company or firm or partnership if joint venture , or each party there to constituting the bidder.
- Details of experience and past performance of the bidder on works of similar nature within the last three years, details of current work in hand and other contractual commitments shall be submitted with full details such as address, contact person, contact number etc.
- Details of work carried out in Govt./Quasi Govt. sector in last five years to be furnished with all relevant details

Cover - II Financial Bid containing the Bill of Quantities with the quoted rate of Contractor. Only those bidders having a valid and active registration and who possess compatible digital signature certificate issued by the competent can participate in the tender.

Bidders are advised to visit the “Downloads” section of e-Procurement website (www.etenders.kerala.gov.in) for detailed instructions on making online payment using Internet Banking facility of SBT or by using NEFT/RTGS facility. Bidders opting for NEFT/RTGS facility of online payment are advised to exercise this option at least 48 hours before the closing of the bid to ensure that payment towards the fee of the tender documents with schedule and EMD are credited and a confirmation is reflected in the e-Procurement

system. The online NEFT/RTGS remittance form provided by e-procurement system for making a NEFT/RTGS transaction is not a payment confirmation. NIC/SBT/HPC shall not be responsible for any kind of delay in payment status confirmation.

All bids/ tender documents are to be submitted online only and in the designated cover(s)/ envelope(s) on the e-GP website. Tenders/bids shall be accepted only through online mode on the e-GP website and no manual submission of the same shall be entertained. Late tenders will not be accepted.

The scanned copies of Registration certificate duly attested by the competent authority of Companies or Chief Engineer / Superintending Engineer/Executive Engineer of PWD/CPWD/TDB as the case may be. Preliminary Agreement in Kerala stamp paper worth Rs. 200/- signed by the contractor, Tender Documents duly filled, e-payment form duly filled shall be submitted online and subsequently in a separate cover physically superscribing the name of work and tender number to the Member Secretary, HighPower Committee for Implementation of Sabarimala Master Plan, Travancore Devaswom Board Head Quarters, Nanthancode, Thiruvananthapuram – 695 003 through **Registered Post/ Speed Post/Courier** before the time and date of opening. Hard copies shall be submitted only after submission of online documents.

The HPC will not be responsible for any error like missing of schedule data while downloading by the Bidder. If the document submission date opening date happens to be a holiday or not working due to any valid reasons, the tender opening process/submission of document will be done on the next working day.
