It is hereby notified for the information of all the employees and Heads of Offices under the Board that the Departmental Test will be conducted on 4th and 5th of May 2018 at Sumangali Auditorium, Devaswom Board Compound, Nanthancode, Thiruvananthapuram as per time table noted below :

D O T – Paper –III (Common)

1. Candidates desiring to appear for the Examination should submit their application to “The Secretary, Office of the Travancore Devaswom Board, Nanthancode, Thiruvananthapuram -03” on or before 10-04-2018 (Tuesday) after which no application will be accepted on any account. The applications should be in the prescribed form which can be obtained from various offices under the Board or can be downloaded from the official website www.travancoredevaswomboard.org. The envelope containing the application should be superscribed as “Application for Departmental Test – May 2018”.
2. The Establishment Employees like Peons and Devaswom Guards appearing for the test for the first time should have completed their period of probation. The Temple employees appearing for the first time should have completed their period of probation and one year full time service. A certificate to the above effect issued by the Head of Office should

- accompany the application. Those who have not completed service as stated above will not be allowed to appear for the test. The Karanma Employees are not permitted to apply for the test.
3. Paper I & II of the Maramath Test will be in English. The Paper I & II of the DOT will consist of two parts each – Part -A (Question from Devaswom Manual) and Part -B (Questions from Sub Group Manual and P.D. Manual). Part –A will be in English and Part- B will be in Malayalam. Paper –III will be in Malayalam.
 4. The fee for each paper will be at Rs. 50/-. The fee should be remitted in the Savings Bank Account of the Devaswom Accounts Officer or in the SB Account No. 126-1-6223 of the Devaswom Commissioner with the Dhanlaxmi Bank.
 5. The fee remitted by the candidates for the test will not be refunded on any account.
 6. The candidates are expected to adhere strictly to the directions given by the supervisory officers. Any candidate who misbehaves or violates such directions will be expelled from the examination hall. Candidates are strictly forbidden from meeting or canvassing examiners directly or indirectly and anyone who attempts to do so will be debarred from appearing for Departmental Tests for such period as the Board may decide and his/her result will be withheld.
 7. No candidate will be allowed to enter the examination hall after half an hour from the commencement of the Test and no candidate will be allowed to leave the examination hall half an hour before the expiry of the examination.
 8. Details of the Test are furnished in the appendix attached. The use of text book will be allowed in answering the question papers except in cases where it is specifically prohibited.
