system. The online NEFT/RTGS remittance form provided by e-procurement system for making a NEFT/TGS transaction is not a payment confirmation. NIC/SBI/TDB shall not be responsible for any kind of delay in payment status confirmation. All bids/tender documents are to be submitted online only and in the designated cover(s)/ envelope (s) on the e-GP website. Tenders/ bids shall be accepted only through online mode on the e-GP website and no manual submission of the same shall be entertained. Late tenders will not be accepted. **The scanned copies of valid TDB license of registered contractors duly attested by the Competent Authority/ Chief Engineer/Executive Engineer of TDB as the case may be. Hard copies of valid TDB license , detailed slip of payment, shall be submitted only after submission of online documents.** TDB will not be responsible for any error like missing of schedule data while downloading by the Bidder. If the document submission date & opening date happens to be a holiday or not working due to any valid reasons, the tender opening process/ submission of document will be done on the next working day.
