## ORDER

At present there are two sanctioned posts in the cadre of Commissioner in the Travancore Devaswom Board in addition to the post of Devaswom Commissioner. The posts of Secretary, Travancore Devaswom Board, Commissioner for Thiruvabharanam and Finance & Accounts Officer are being filled by officers in the rank of Commissioner and Deputy Devaswom Commissioners very often by shifting the posts from one office to another depending on administrative exigency. Offate the post of Secretary was filled up by an officer in the rank of Commissioner vide orders referred (i) above by upgrading the same from the rank of Deputy Devaswom Commissioner.

The post of Finance & Accounts Officer carries several important functions with regard to the financial matters of the Board. As per the Devaswom Manual he is the controlling Officer for all the staff working in the Accounts Department. He is the head of the Department of Accounts under the Board. He is also supervising the function of Devaswom Accounts Officer. However at present Finance & Accounts Officer and Devaswom Accounts Officer are in the same rank of Deputy Devaswom Commissioner. So the Board resolved to upgrade the post of

Finance & Accounts Officer to the cadre of Commissioner. Considering all the above aspects and on administrative grounds, the following transfers of Gazetted Officers are ordered with immediate effect.
