Certificate from the revenue authorities either at the time of joining duty or within seven days therefrom, to the effect that she is not having any permanent employment under Government / Public Sector / Autonomous Institutions / Travancore Devaswom Board. In case he / she cannot produce the same at the time of joining duty, he / she shall produce a declaration to the above effect.

The maximum time that can be granted to candidates to join duty by the appointing authority is 15 days. The appointment should be subject to the terms and conditions of National Pension Scheme.
