**Proceedings of Travancore Devaswom Board**

**Sub:- Fees Schedule for conducting civil cases for Travancore Devaswom Board in Lower Courts and other forums.**

Considering the necessity of adopting fees structure/ schedule for conducting Civil Cases in Lower Courts and other forums, the Board is pleased to approve a fees structure/ schedule with effect from 01.03.2021 as follows.

**1. ORIGINAL SUITS**

Original Suit fees shall be calculated on the value of the subject matter of the suit.

- a) On the first sum of Rs. 5000/- -at 10%
- b) On the sum above Rs. 5000/- up to 50,000/- -at 08%
- c) On the sum above Rs. 50,000/- up to 1,00,000/--at 05%
- d) On the sum above Rs. 1,00,000/-up to Rs. 5,00,000/--at 03%

It is subject to the minimum of Rs. 2,500/- and Maximum of Rs. 20,000/-. In case where fixed court fee is paid the minimum fee shall be Rs. 3,000/-

**2. EXECUTION PETITION**

In execution cases, the advocate fee shall be calculated at the rate of 50% of the fee calculated at the rate specified in original suit as above, subject to a minimum of Rs. 1250/-.

**3. REGULAR APPEALS**

In regular appeal, the advocate fee shall be paid at the rate specified for original suits above, subject to a minimum of Rs. 3000/- and maximum Rs. 20,000/- In case where fixed court fee is paid the minimum shall be Rs. 3000/-

**4. OTHER AUTHORITIES INCLUDING QUASI - JUDICIAL BODIES.**

For conducting petitions before the other authorities including Quasi-Judicial bodies are subject to the minimum of Rs. 3000/- and maximum of Rs. 6000/-


Note:

1. Clerical fee minimum Rs. 500/- maximum Rs. 1500/-
2. The fee for drafting plaints, appeals, written statements, original applications or petitions under different enactments, objections to petitions stated above shall be Rs. 1500/- per case. It shall be in addition to the fee for conducting such case. No fee shall be paid for drafting interlocutory applications/objection thereof.
3. Only half of the fee prescribed shall be payable in uncontested cases and cases settled out of court without any enquiry.
4. Appearance fees for each posting minimum Rs. 200/- subject to the maximum of Rs. 5000/- for all appearance.
