Hard copies shall be submitted to this office subsequently within 10 days after online submission of bids in a separate cover by registered post/speed post.The TDB will not be responsible for any error like missing of schedule data while downloading by the Bidder. If the document submissions date, opening date happen to be a holiday or not working due to any valid reasons, the tender opening process/submission of document will be done on the next working day.
