Late tenders will not be accepted. **The scanned copies of valid TDB license/PWD license of registered contractors duly attested by the Competent Authority/ Chief Engineer/Executive Engineer of TDB as the case may be.Hard copies of valid TDB license /PWD license, detailed slip of payment, shall be submitted only after submission of online documents.** TDB will not be responsible for any error like missing of schedule data while downloading by the Bidder. If the document submission date & opening date happens to be a holiday or not working due to any valid reasons, the tender opening process/ submission of document will be done on the next working day.
