Only those bidders having a valid and active registration issued by Kerala PWD /Travancore Devaswom Board /Central PWD / Kerala Water Authority etc. and who have successfully completed at least one similar work costing more than 40% (Forty Percentage) of the estimated cost of the work within the last five years. A certificate to this effect from the agreement executing authority of the completed building work shall invariably be submitted along with the tender documents.

The hard copies of certificates and documents, as detailed in clause 4.4 of Part-I Instructions to the Bidders, shall be submitted subsequently after online submission of bids in a separate cover by Registered post/Speed post/ Courier before the date and time of opening of technical bid. Price Bid shall only be submitted through online. Details regarding remittance of Bid Submission Fee, Bid Security, Bid preparation and submission are mentioned in the bid document.

Special Conditions of Contract

1. The DI pipes to be supplied under this contract shall be manufactured as per IS 8329/2000 as amended from time to time and shall bear ISI certification

mark. The pipe shall be procured from manufacturers only and tested at the factory by authorized Engineers or by third party inspection agencies recommended by the tendering authority (TDB) before delivery to worksite. The final decision in this matter entirely belongs to the discretory power of the tendering authority. The cost of testing shall be met by the contractor within the quoted rate and no separate claim shall be allowed.

- 2. (a) The contractor shall arrange for joint pre delivery testing of the pipes/materials through third party agency approved by TDB in presence of the officer authorized by the tendering authority in case the tendering authority decides so.
- (b) The pre delivery testing of pipes/materials does not relieve the tenderer of his responsibility on the quality of the pipes brought to site and the tenderer will be fully responsible for the quality of materials used for the work.
- (c) The make of pipes and specials once accepted shall remain unchanged. Only on valid/convincing reasons any such change on make of materials shall be considered. The final decision in this matter entirely belongs to the discretory power of the tendering authority
- 3. The contractor shall guarantee satisfactory performance of the pipeline for a period of 18 months after completion of supply. During this guarantee period, any replacement that shall be necessitated will have to be carried out by the contractor without any extra cost and within the shortest possible time failing which the work shall be arranged/ attended by the at the risk and cost of the contractor. Intimation in this regard will be furnished by the Assistant Engineer on the Telephone Number /email id provided by the contractor.
- 4. Under no circumstances, any price variation shall be allowed for the pipes and other materials to be supplied as per this contract and the prices quoted shall remain firm.
- 5. The retention amount equivalent 10% of total value shall be retained with Travancore Devaswom board until the guarantee period is over.
- 6. The contractor shall be bound to carry out works up to 15% in excess of the quantity specified, if required during actual execution on the same terms and conditions
- 7. The contractor shall take complete care in handling of pipes and materials at the work site and shall be responsible for the safety of men and materials brought to site

Tender documents and Tender schedule can be downloaded free of cost from thee-GP, Website (www.etenders.kerala.gov.in). Bidders shall remit the fee of the tender documents with schedule and EMD using the online payment options of e-procurement system only. Bidders are advised to visit the "Downloads" section of e-procurement website: www.etenders.kerala.gov.in for detailed instructions on making online payment using Internet banking facility of SBI or by using NEFT/RTGS facility. Bidders opting for NEFT/RTGS facility of online payment are advised to exercise this option at least 48 hours before the closing of the bid to ensure that payment towards the fee of

the tender documents with schedule and EMD are credited and a confirmation is reflected in the e-procurement system. The online NEFT/RTGS remittance form provided by e-procurement system for making a NEFT/RTGS transaction is not a payment confirmation. NIC/SBI/HPC shall not be responsible for any kind of delay in payment status confirmation. All bids/ tender documents are to be submitted online only and in the designated cover(s)/ envelope(s) on the e-GP website. Tenders/bids shall be accepted only through online mode on the e-GP website and no manual submission of the same shall be entertained. Late tenders will not be accepted. The scanned copies of valid license of registered contractors duly attested by the Competent Authority / Chief Engineer / Executive Engineer of TDB as the case may be. The TDB will not be responsible for any error like missing of schedule data while downloading by the Bidder. If the document submission date, opening date happen to be a holiday or not working due to any valid reasons, the tender opening process/submission of document will be done on the next working day. All conditions prevailing in this department as per NIT / Revised PWD Manual regarding tenders are applicable to this tender also.
