All bids/tender documents are to be submitted online only and in the designated cover(s)/ envelope (s) on the e-GP website. Tenders/ bids shall be accepted only through online mode on the e-GP website and no manual submission of the same shall be entertained. Late tenders will not be accepted. *The scanned copies of valid license of registered contractors duly attested by the Competent Authority/ Chief Engineer/Executive Engineer of PWD or TDB as the case may be.* The bidders shall also submit the last 3 years income tax return acknowledgment receipt numbers before the payment of work bill. Hard copies shall be submitted only after submission of online. TDB will not be responsible for any error like missing of schedule data while downloading by the Bidder. If the document submission date & opening date happens to be a holiday or not working due to any valid reasons, the tender opening process/ submission of document will be done on the working day as mentioned above. All conditions prevailing in this department as per NIT/Revised PWD Manual regarding tenders are applicable to this tender also.
