### NOTICE INVITING RE-TENDER

#### e- Government Procurement (e-GP)

1. The Member Secretary, High Power Committee for the Implementation of Sabarimala Master Plan, III Floor Travancore Devaswom Board Building, M.G Road, Opp. Govt. Ayurveda College, Puthenchantai, Thiruvananthapuram - 695 001 for and on behalf of the High Power Committee for the Implementation of Sabarimala Master Plan invites online bids for the work detailed below from the Registered Civil/ Electrical/ composite category contractors in central government departments, Bidders of Kerala PWD/ Central PWD/Other Central or State Government Departments/ State or Central Public Sector Undertakings etc. satisfying the qualifications criteria prescribed in the Instruction to Bidders and conditions specified in the G.O (Ms) No. 27/2020/PWD dated 26/02/2020. The bidders are permitted to take part in composite tender up to their tendering limits as stipulated in the Bid. The Bidders will have to obtain an undertaking from his CONSORTIUM partner of Electrical/ Electronics/ Civil contractors having valid Electrical/ Electronics/ Civil Licenses from PWD/ Central PWD/ Other Central or State Government Departments/ Department of Electrical Inspectorate, Govt. of Kerala/ State or Central Public Sector Undertakings etc. if the Bidder alone is not having all the relevant license required for bidding. A copy of M.O.U (Memorandum of Understanding) in this respect entered with the electrical/electronic/civil contractor should be furnished within 30 days after execution of agreement. If the bidder himself is a licensed contractor in all applicable categories, this provision shall be dispensed with. In the event of the tender being submitted by a joint venture/consortium, it must be signed by the lead partner holding a valid power-of attorney authorizing him to do so, such power of attorney to be produced with the tender.)
2. A certificate to this effect from the agreement executing authority of the completed similar work shall invariably be submitted along with the tender documents failing which the tenders will not be accepted. The certificate should contain the details such as name of work, agreement number, date of start and completion as per agreement, completed amount of work etc.

Bid documents including the Bill of Quantities (BoQ) can be downloaded free of cost from the the e- Government Procurement (e-GP) Website [www.etenders.kerala.gov.in](http://www.etenders.kerala.gov.in). All bid documents are to be submitted online only and in the designated cover(s)/ envelope(s) on the e-GP website. Tenders/ Bids shall be accepted only through online mode on the e-GP website and no manual submission of the same shall be entertained. Late tenders will not be accepted. A bid submission fee shall be remitted online during the time of bid submission.
4. Bid document and Price Bid shall only be submitted through online. Details regarding remittance of Bid Submission Fee, Bid Security, Bid preparation and submission are mentioned in the bid document.
5. The hard copies of certificates and documents, as detailed in clause 4.4 of Part-I Instructions to the Bidders, shall be submitted **subsequently after online submission** of bids in a separate cover by Registered post/Speed post/ Courier before the date and time of opening of technical bid. Price Bid shall only be submitted through online. Details regarding remittance of Bid Submission Fee, Bid Security, Bid preparation and submission are mentioned in the bid document.
6. The technical bids shall be opened online on 06.07.2024 at the office of the Member Secretary, High Power Committee for the Implementation of Sabarimala Master Plan, III Floor Travancore Devaswom Board Building, M.G Road, Opp. Govt. Ayurveda College, Puthenchanthai, Thiruvananthapuram - 695 001 in the presence of the Bidders or their authorized representatives who wish to attend at the above address. If the tender opening date happens to be on a holiday or non-working day due to any other valid reasons, the tender opening process will be done on the next working day at same time and place. The technical bids submitted by the Bidders will be

evaluated as per the terms and conditions set out in the bid document for pre-qualification and the price bid of only the pre-qualified Bidders shall be opened. The date and time of opening of the Price bid will be intimated by e- mail to the Bidders who are Pre-qualified after evaluation of Technical Bids and will be published on the notice board at the office of the Tender Inviting Authority.

7. Online Tenders/ Bids are to be accompanied by a scanned image of the preliminary agreement executed in format attached in section 4 Kerala Stamp Paper worth Rs.200/-. Tenders/ Bids received online without the details mentioned in clause 4.4 of Part-I Instructions to the Bidders will not be considered and shall be summarily rejected.
8. More details can be had from the NIT or the Office of the Member Secretary, High Power Committee for the Implementation of Sabarimala Master Plan, III Floor Travancore Devaswom Board Building, M.G Road, Opp. Govt. Ayurveda College, Puthenchanthai, Thiruvananthapuram - 695 001 during working hours. All other existing conditions related to bidding in force in the Kerala Public Works Department will be applicable in this tender /bid also unless expressly defined in the bidding document. The Tender Inviting Authority/employer shall not be responsible for any failure, malfunction or breakdown of the electronic system while downloading or uploading the documents by the Tenderer /Bidder during the e-procurement process.
9. Details required for e-payment (Details of bank account having core banking facility and e-mail address of the contractor) shall be furnished along with the tender. Tenders not accompanied by these details will be rejected. All subsequent Government orders connected to tenders / bids and any revision in the rates of taxes would also be applicable to this tender / bid.
