Bidders opting for the NEFT/RTGS facility of online payment are advised to exercise this option at least 48 hours before the closing of the bid to ensure that payment towards cost of tender documents with schedule and EMD are credited and a confirmation is reflected in the e-Procurement system. The online NEFT/RTGS remittance form provided by e-procurement system for making a NEFT/RTGS transaction is not a payment confirmation.

All bids tender documents are to be submitted online only and in the designated cover(s)/ envelope(s) on the e-DP website. Tenders/bids shall be accepted only through online mode on the e-DP website and no manual submission of the same shall be entertained. Late tenders will not be accepted.

The scanned copies of Registration certificate duly attested by the concerned Chief Engineer/Superintending Engineer/Executive Engineer of PWD/TDB should have enrolled in this department have Preliminary Agreement in stamp paper worth Rs. 200/- signed by the contractor, Tender Documents duly filled, e- payment form duly filled shall be submitted online and subsequently in a separate cover physically super scribing the name of work and tender number to the **Executive Engineer**, **Works Department**, **Trivandrum** through **Registered Post/ Speed Post** before the time and date of opening. Hard copies shall be submitted only after submission of online documents.

The Travancore Devaswom Board will not be responsible for any error like missing of schedule data while downloading by the Bidder. If the document submission dates opening date happen to be a holiday or not working due to any valid reasons, the tender opening process/submission of document will be done on the next working day.
