Tender Notification

Case making for Hollow Book Binding for Sreemad Bhagavat Geetha- 2500 Nos.

Sealed competitive Tender are invited by Travancore Devaswom Board, from reputed printing presses equipped with case making and four colour printing facilities for the following item of work.

1. Sreemad Bhagavat Geetha - 2500 cases for hollow back book binding style.


Particulars of the work


1. The case shall be pasted with multi colour print of the given original.
2. The Board for the cover to be used shall be of mill board variety of 1.5 mm thickness. The thickness of the board is subject to change in proportion to the thickness of the Book.
3. Size of the Sreemad Bhagavat Geetha Demy 1/8 (22.5 cm. X 30.5 cm. ½ lb Board, 120 GSM art paper multi colour Printing with Gloss Lamination) which is exclusive of the width of the spine. (Suit the cut size)
4. The cased book shall have appropriate square extending from the edge of the book and a groove on the back side of the front page to facilitate opening of the book.
5. The front and back of the cover to be matt laminated. (gloss is also preferable, which will be decided later, Hence the rate for each of the items may be quoted)
6. Tenders shall be submitted to the Director of Cultural & Archaeological Department in sealed covers. Best specimen of similar work done by the bidder may also be sent.

7. Each Tender shall be accompanied by an E.M.D. of Rs.5000/- either in cash/DD infavour of Devaswom Commissioner at the time of opening.
8. Last date for the receipt of Tender at the office of the Cultural & Archaeology Director is at **11.30 PM** on **25.06.2025**
9. The rate quoted for this work shall be inclusive of the rate of multi colour printing, case making, Lamination and all taxes. The items are to be delivered at the store of the Travancore Devaswom Board situated in the premises of the Board office.
10. Dummy of the case Specifying the size and width of spine (thickness of the book) of the case will be made available to the successful bidder together with the work order for guidance.
11. Dummy can be had from the office of the under signed during the validity period of the tender.
12. System work for the front and back sides of the cases shall be done by the successful bidder and forwarded for approval.

No tender will be accepted after the date and time specified. The tender which has not been supported by sample in proof of the efficiency of the bidder is liable for rejection at the discretion of the undersigned. Tenders will be opened at **11.45 AM** on **25.06.2025**
