## ORDER

The Secretary, Kerala Devaswom Recruitment Board has forwarded the list of 32 candidates from List 1 (Candidates qualified from Kshethra Kalapeedom) and 5 candidates from List 2 (Candidates qualified from institution other than Kshethra Kalapeedom) advised for appointment to the post of Nadaswaram Cum Watcher in the existing vacancies of Travancore Devaswom Board. In pursuance of the letter cited, the following 37 (ThirtySeven) candidates are appointed as Nadaswaram Cum Watcher in the scale of Pay Rs.23000-700-27900- 800- 31100- 900- 38300 -1000-42300-1100-47800-1200-50200 in various stations of Travancore Devaswom Board. The appointees will be on probation for a period of two years on duty within a continuous period of three years. They are directed to report before the officers concerned with the following certificates for verification.

1. Certificates in original to prove age and qualification with attested copies.
2. Medical Certificate as prescribed in GO (P) No 20/2011/P&ARD dated 30/06/2011
3. Conduct Certificate from Gazetted Officer.
4. Community Certificate, if applicable in original.
5. Certificates from the Revenue Authorities either at the time of joining duty or within 7 days therefrom, to the effect that he is not having any permanent employment under Government / Public sector / Autonomous Institutions / Travancore Devaswom Board. In case he cannot produce the same at the time of joining duty he shall produce a declaration to the above effect.
6. The copy of Identification Certificate is also attached with this order. Concerned officers should verify the photo and signature of the candidates with the identification certificates. The photograph and signature of the candidates may be verified and the fact may be recorded by the Appointing Authority on the identification certificate itself. If there is any discrepancy, the candidates should not be allowed to join duty and the fact should be reported forthwith. After the candidate is allowed to join duty, the identification certificate is verified and if found acceptable it may be kept pasted in his service book.
7. The details of the candidates duly filled up (Performa attached) in the performa should be verified and the same should be sent to this office without delay.

The maximum time that can be granted to candidates to join duty by the Appointing Authority is 45 days. The appointment should be subject to the terms and conditions of National Pension Scheme . The advice of the candidates is subject to the sub rule 17 of rule 7 of the Kerala Devaswom Recruitment Rules 2015.


