Bidders opting for NEFT/RTGS facility of online payment are advised to exercise this option at least 48 hours before the closing of the bid to ensure that payment towards the fee of the tender documents with schedule and EMD are credited and a confirmation is reflected in the e-procurement system. The online NEFT/RTGS remittance form provided by e-procurement system for making a NEFT/RTGS transaction is not a payment confirmation. NIC/SBI/TDB shall not be responsible for any kind of delay in payment status confirmation. All bids/tender documents are to be submitted online only and in the designated cover(s)/ envelope (s) on the e-GP website. Tenders/ bids shall be accepted only through online mode on the e-GP website and no manual submission of the same shall be entertained. Late tenders will not be accepted. **PWD contractors should register in Travancore Devaswom Board as a contractor by remitting the required fees, before executing the agreement.** The bidders shall also submit the last 3 years income tax return acknowledgment receipt numbers before the payment of work bill. All other existing conditions related to bidding in force in the Travancore Devaswom Board will be applicable to this tender also unless expressly defined in the bidding document. All subsequent government orders connected to tenders and any revision in rates of taxes would be also be applicable to this tender. The tender inviting authority shall not be responsible for any failure, malfunction or breakdown of the electronic system while downloading or uploading the documents by the bidder during the e-procurement process.
