- The work should be done as per the directions of department officials at the site. The detailed hardware, technical Specifications and make of materials to be used for the work are specified in the tender documents. All materials, accessories, and appliances, etc. having approved quality should be used for the work.
- The rate quoted should be inclusive of GST and all taxes

The online NEFT/RTGS remittance form provided by e-procurement system for making a NEFT/RTGS transaction is not a payment confirmation. If the document submission date, opening date happen to be a holiday or not working due to any valid reasons, the tender opening process/submission of document will be done on the next working day.
